Department Head Reports

Veterans & Human Services Director Michael Holzhauser said Veterans & Human Services Deputy Director Irene Pierce has been doing a lot of collection work and mailing out notices.

Holzhauser updated the board on the number of phone calls the office has made and received, and the number of in-person meetings.

County Development Deputy Director Richard Haugen said Pipestone System is opening a new swine production unit in Brookings County. He said there is an open house March 7th at 10:00 a.m.

Be it noted, Chairperson Jensen is authorized to sign a letter noting Brookings County's obligations incurred as part of the FEMA pre-disaster mitigation planning process as a participant in the multi-jurisdictional plan.

Director of Equalization Chris Lilla said the last day to appeal to local boards is March 16th. Lilla said the Brookings County Board of Equalization will meet April 11th at 8:30 a.m.

Finance Officer Vicki Buseth said they've been working on the Annual Report. Buseth said the public surplus sale has been going well; the sale will end March 9th at 3:00 p.m.

Sheriff Martin Stanwick said Deputy Sean Doremus is training to become a Drug Recognition Expert.

Stanwick said there are 31 inmates in jail. Stanwick said he met with the States Attorney, the SDSU Police Chief, the Brookings City Police Chief, and the University's Attorney and discussed opening up communication lines between the entities.

Stanwick said he presented the jail expansion project to the City Council in Volga.

Stanwick said he was asked to be on the board for My Neighbor. He also said the Sheriff's Department is teaming up with Basin Electric to help with the fundraiser Brave the Shave.

Highway Superintendent Richard Birk said he and his staff have been working on the on-line training on harassment prevention and maintaining a drug free workplace.

Birk said the seasonal weight restrictions are in effect and will be on until road conditions can tolerate legal loads.

Bartley asked if the board should to more advertising in addition to the public notice that will be published in the legal papers. Bartley suggested the radio, Shopper, etc. He said this is a huge project and would like more public input because it will affect everyone in Brookings County.

Commission Department Director Stacy Steffensen presented the Commission Department Director's Report.

Steffensen asked the board if they would like to participate again in the Brookings Register's "Momentum" magazine. Steffensen said the cost would be approximately \$800.00. Commissioner Krogman said it was well done last year and has no problem spending the money on it again. By consensus, the board agreed to participate in the Brookings Register's "Momentum" magazine.

Steffensen said they are currently having all employees take part in an on-line training on harassment prevention and maintaining a drug free workplace. Steffensen encouraged the board to take part in the on-line training as well.

Steffensen said the redesign of the website is coming along. She said she hopes to go live by the end of May.

Steffensen discussed upcoming dates.

Chief Deputy States Attorney Teree Nesvold said she continues to work on the ordinances, as well as the statistics.

COMMISSIONERS' REPORTS & DISCUSSION

Commissioner Pierce said they've finished the administration portion of the ordinances. Pierce met with the ordinance subcommittee working on lakes; attended the Governmental Affairs Forum; and attended the public meeting at the Detention Center.

Commissioner Krogman attended and discussed the meeting he had with Medary Township. Krogman attended the public meeting at the Detention Center.

Commissioner Miller attended the Jail Expansion Committee Meeting; attended the public meeting at the Detention Center; attended a bid opening for the Weed Department; and met with Commissioner Cindy Heiberger with Minnehaha County about the Juvenile Detention Alternative Initiative. Miller said they would like them to put together a key committee and start discussions on alternative ideas with juveniles. Miller said they would like to know if Brookings County is interested and would like to know by March 17th. By consensus, the board agreed to move forward with the idea.

Commissioner Jensen attended the Governmental Affairs Forum, and attended a meeting with architect BKV.

ADJOURNMENT

Motion by Krogman, seconded by Bartley to adjourn. Motion carried. The next regular scheduled meeting is Tuesday, March 21, 2017 at 8:30 a.m.
