Department Head Reports

Community Health Nurse Jen Burns presented the WIC/Community Health 2nd Quarter Report. Burns said they continue to provide supplemental nutritional foods, nutrition education, support, and referrals to clients, to local Brookings County resources.

She said they continue to reach out to parents of adolescents with education related to adolescent recommended vaccines.

Burns said they will be contacting the schools in August to schedule school screenings. She also said the plan this year is to complete the majority of school services in September.

Burns said the staff completed an eight hour education session on Mental Health First Aid training.

County Development Director Robert Hill said the City of Bushnell submitted paperwork showing that they spent \$4,188.85 to have a severe weather siren installed in their community.

Hill said the State and Local Agreement for the 3rd Quarter is due.

Be it noted, Vice-Chairperson Michael Bartley signed the 3rd Quarter SLA Report for FY2018 and time sheets for Hill.

Hill said he's been updating ordinances with States Attorney Teree Nesvold.

Hill said the EOC Command trailer was used at Pioneer Park by the City of Brookings Police Department for the Arts Festival.

Hill said County Development Deputy Director Richard Haugen monitored severe weather and posted messages on social media during a recent storm. Hill discussed some of the damage that occurred throughout Brookings County during the July 19th flood. Hill said the Salvation Army contacted his office and brought down 46 basement buckets, which consist of materials needed to help clean out basements that received water damage.

Hill said he attended the NACo Conference in Davidson County, TN.

Hill discussed upcoming dates.

Highway Superintendent Richard Birk said he's been helping Scott Bjerke on a culvert project in Oslo Township. Birk said he checked on a culvert under County Highway 12 that was allegedly plugged. He said he found no obstruction and said the ends were clear.

Finance Officer Vicki Busetth said the Sheriff's Office sold one mobile home for non-payment of taxes. She thanked the Sheriff's Department for working so hard to collect those non-paid property taxes.

Be it noted, the expenditure adjustments for the month of June 2018 were presented to the board. \$7,807.54 was transferred to allocate highway department expenditures to other county departments for work performed and supplies furnished by the highway department.

Be it noted, the Register of Deeds Statement of Fees collected for the month of June 2018 in the amount of \$36,330.50 was presented to the board.

Weed Department Supervisor Misty Moser said they are done spot-spraying county roads. She said they are now mowing DOT and County roads.

Brookings County Outdoor Adventure Center Director Kristin Heismeyer said they had water up to the doors of the facility, but there was no water damage to the inside of the facility.

Heismeyer said they are working on re-branding the Outdoor Adventure Center and getting a new logo.

Heismeyer said they are also working on fall programming. She also said they purchased an archery tag game for the range.

Veterans & Human Services Director Michael Holzhauser said he went to the NACo Conference and found it very informative.

Sheriff Martin Stanwick said Assistant Sheriff Scott Sebring is in charge of the mobile homes, and said he does a really good job collecting those non-paid property taxes.

Stanwick said there are 147 individuals participating on the 24/7 program.

Stanwick said Jail Administrator Bart Sweebe is at a Mental Health First Aid Training.

Stanwick said the basement of the Sheriff's Department flooded. He said an AED Defibrillator was ruined because of the flood and will have to be replaced.
