WHEREAS, the Brookings County Highway Department will need new 2021 MOTOR GRADER; and

WHEREAS, STATE OF MINNESOTA has recently gone through a competitive bidding process for 2021 JOHN DEERE 772G, such bidding process culminating in the bids being opened on August 2020.

WHEREAS, RDO Equipment Co, was the lowest responsible bidder under such STATE OF MINNESOTA, bid process and RDO Equipment Co is willing to sell to Brookings County under the same terms and options as available to STATE OF MINNESOTA, a copy of such bid specifications and bid having been filed at the Brookings County Finance Office; and

WHEREAS, the pursuant to SDCL 5-18A-22, Brookings County is authorized to purchase supplies or services from any active contract that has been awarded by any governmental entity by competitive sealed bids or competitive sealed proposals or from any contract that was competitively solicited and awarded within the previous twelve months;

NOW THEREFORE BE IT RESOLVED that the Brookings County Highway Department is hereby authorized and directed to contract for 2021 John Deere 772G, with RDO Equipment Co based upon the bid price, or less, established through the competitive bidding process of STATE OF MINNESOTA.
